	Middleton Leisure Centre / pitches Member briefing for New Forest Village meeting 10 <sup>th</sup> October 2012 The current leisure centre closed on 29 <sup>th</sup> July to make way for refurbishment works which will continue until March 2013. Funding for the project comes from Sport England (Inspired Facilities Fund), Leeds City Council (Sport & Active Lifestyles, Adult Social Care and Parks & Countryside) and Section 106.	
	The centre will provide the following facilities:      4 court sports hall     Dance studio     William Gascoigne Community Room (with kitchen)     1 squash court     Soft play room     Multi purpose room     'Changing Places' disabled changing facility     Improved indoor and outdoor changing rooms     Youth room     Multi use games area     3G pitch     Improved disabled car parking     Garden area     Children's play area for the play group	

This will allow the centre to open its doors to a wide range of community users, from sports enthusiasts (both indoor and outdoor) to dance groups, playgroup, Adult Social Care, older people and youth groups as well as catering for meetings, parties and training courses.

For example, at least 20 places for customers with learning disabilities who live locally will be provided and will be supported by staff from Adult Social Care's Fulfilling Lives to attend the base and take part in the programme of available activities across the centre. This will achieve all four key principles of the Valuing People Strategy; Rights, Independence. Choice and Inclusion in supporting customers to move out of segregated settings into truly integrated community buildings.

Works have also been continuing outside the centre, managed by Parks & Countryside:

Planning consent was acquired in December 2011 for the remainder of the enhancement works to the land surrounding Middleton Leisure Centre to provide:

- The realignment of the football pitches to the south of the Leisure Centre to create 3 senior football pitches and 2 junior football pitches.
- The installation of a pitch perimeter barrier, including dog-proof weld mesh around the western junior football pitch.
- The installation of a goal end to the north of the playing pitches.
- The construction of various link paths throughout the site.
- The installation of ball stop fencing to the eastern and southern end of the site.
- The installation of fencing to the western side of the site, including A-frame motorcycle barriers.
- The installation of fencing to delineate the boundaries between the playing fields and St George's Centre.
- Planting of heavy standard trees throughout the site.
- Initial works towards the construction of an access road to the rear of the main Leisure Centre car park to Leeds Corinthians / LCC rugby ground and southern playing pitches.
- All pitches to be drained and levelled including the installation of soak aways where required.
- Installation of pitch perimeter barriers, including dog-proof weld mesh to the 3 senior football pitches.
- The construction of further link paths throughout the site.
- The provision of site furniture throughout the site including interpretation boards, litter bins and benches.
- Further planting of trees and shrubs throughout the site.

The enhancement of this area will create one of the largest outdoor sporting facilities in the south of the city.
